The Sealed Quotations will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs 31st Jan, 2022 at the office of Janakpurdham Sub-Metropolitan City, Janakpurdham. Sealed Quotations should be valid for a period of 45 days after opening date and must be accompanied by a bid security amounting to a minimum of as specified above which shall be valid for 30 days beyond the validity period (i.e. 75 days) of the quotation after deadline for Bid submission last date.
